Salvage in Stairville, PA yielded a 1972 or 1973 vintage International Travelall V-8 ambulance with a raised roof and a wheelbase stretch, on top of which the body, glass, interior and "what lights are on the vehicle" all appeared to be in solid shape. The body builder could not be positively ascertained in the absence of exterior badges, but the Springfield Equipment Corporation of Springfield, OH is a likely candidate as it completed many similar vehicles. William also reports that Engler's yard contains a pair of Cadillac ambulances from 1963 and the 1950-6 period, though he advises "those two cars are pretty beat."

For those of us in search of a wholesome alternative to online porn, one of the most alluring aspects of the Internet is that it allows you to peruse hundreds or even thousands of cars from the comfort of your own home in an astoundingly short span of time. One professional vehicle that beckoned to Your Editor's from cyberspace was a battered but remarkably unmolested 1953 Chevrolet extended-wheelbase ambulance, constructed by the National

Body Manufacturing Company of Knightstown, Indiana and offered at just \$4,995 by Classical Gas of Eaton, Colorado. Faint lettering from the "Columbus Ambulance Service," which the sellers believe was in Nebraska, is still visible above the side windows, and the car also features new radial white wall tires, a 235 cubic inch "Stovebolt" six linked to a three-speed manual transmission, a reupholstered front seat and a well-preserved patient compartment with a sliding partition and built-in supply cabinets. ## HISTORIC AMBULANCES HEADING TO ALBANY

Your Editor recently received a letter from New Paltz, NY Chapter member Myron Gittell, who has been hard at work on an exhibit of historic ambulances that is scheduled to run at the New York State Museum in Albany from November 20th, 2004 through September 11th, 2005. While preparations are "moving along," he reports, "we don't have an early 30's ambulance to fit between the 1926 Cunningham that we're borrowing from the Towe Museum (in Sacramento, CA) and the 1939 Pontiac Superior" from the N.Y. State Museum's own collection, which served the Adirondack Mountain towns of Blue Mountain Lake and Long Lake until 1962. "Robert Cosgrove's 1932 Nash," bodied by A.J. Miller of Bellefontaine, OH, "would have been almost ideal as it's a beautiful rig and saw service in New York State," Myron asserts, "But he's gone South with it and it was For Sale for \$175,000 last year and contact with him was lost." Any reader who can help ascertain the car's current whereabouts should e-mail Myron ASAP at Myrongit@yahoo.com. Another lead he's looking into involves a comparatively-rough but no less rare 1932 Cunningham ambulance that was owned by a PCS member named Mark Carlson in the late 1980s and sold at a 1996 Kruse Auction for \$1,300. "Kruse Auction results are easy to find on their website," Myron adds, "especially for a Cunningham as that ambulance was the only Cunningham listed as sold on their site which goes back maybe a dozen years."

As the exhibit will have space for fifteen vehicles chronicling the evolution of patient transport in the Empire State, there are several other vehicles on the Museum's wish list. Car-based ambulances from the 1930-55 period, ambulance/funeral coach "combinations" and early truck-based ambulances from the 1970s or early 1980s are still being sought, especially ones where the chassis or coachwork was constructed in New York State; notable examples include Pierce-Arrow cars from Buffalo, Rochesterbuilt Cunninghams, and modular ambulance bodies from Medical Coaches of Oneonta or the Franklin Body and Supply Company of Brooklyn. Ambulance squads and individuals with period photos, uniforms, first aid manuals and medical equipment are also encouraged to contact New York State Museum curator Geoffrey N. Stein at (518) 473-3810 or gstein@mail.nysed.gov. Assuming it will serve as an incentive, all borrowed objects will be insured and the Museum plans to pay for the transportation of borrowed materials to and from Albany. A large turnout can be expected for the exhibit as the Museum attracts hundreds of thousands of visitors each year and the display's opening will coincide with the dedication of an EMS memorial in Empire State Plaza.

#### POLICE RECEIVE EMT TRAINING

The paramedic movement of the late 1960s and early 1970s marked a great leap forward in the history of emergency medicine, saving hundreds of thousands of lives each year through the realization that more Americans would survive heart attacks. accidents and other severe traumas if urgently needed care was brought to the patient instead of the other way around. While firefighters and rescue squads have traditionally rendered this assistance. the Town of Montgomery, NY recently arrived at the so-simple-it's-brilliant conclusion that police officers should receive emergency medical technician training on the grounds that they are usually the first people to arrive on an accident scene. "Cops are the logical ones to have EMT training, because they're already out on the road," explains Joseph Poptanich of the Ulster County Ambulance Association, which has already put two Montgomery police officers through a six month course and expects to have all seven of the department's full-time officers trained by early 2005. In the four months since he became the first Montgomery policeman to complete the EMT program, Alex Landolina has provided lifesaving medical assistance on two dozen different occasions, doing everything from administering drugs to an asthma attack victim to stabilizing a critically-injured man whose ATV crashed into a tree, overturned and hurled him against another tree. "As a police officer, my job is not just to prevent crime but to assist the community," Landolina told reporter Alice Kenney for an article published in the April 16th issue of the Middletown, NY TIMES HERALD-RECORD, adding that "It's a nice feeling to show up on an accident scene and know how to help."
